ELIGIBILITY AND FORMAT

The author of an entry must be a law student in good standing at an American Bar Association-accredited law school located in the state of Texas during the 2011-12 school year. Eligible authors intending to submit an entry should go to www.ilstexas.org/ttlq.php to view past articles of the Texas

Transnational Law Quarterly for examples of proper style for their entries.

Entries should be three to ten double-spaced pages with one-inch margins on 8 1/2" x 11" paper and conform to the style requirements of the Blue Book, 17th edition. The entry must be submitted (preferably by e-mail) with a cover letter listing the author's name, law school, expected year of graduation, current address (and if different, permanent address), and e-mail address. If a hard copy is provided, an electronic version of the article must nevertheless be provided. Only one entry per author will be accepted. All entries must be original, have only one author, and be of publishable quality. If the entry has been submitted for publication or published elsewhere, this must be stated in the letter together with details of when and where published. Entries may have been prepared for course credit or for journal submission. On submission, all entries will become the property of the International Law Section, State Bar of Texas and may become eligible for consideration to be published in the Texas Transnational Law Quarterly.

CRITERIA FOR AWARDS

Entries will be judged based on contribution to the international legal profession, analysis and research, timeliness, originality, proper spelling and grammar, and proper format. The International Law Section, State Bar of Texas reserves sole discretion in its selection of entries for awards including (without limitation) the right to make no award if no entry, in its sole discretion, is of sufficient quality or to limit the number or type of awards provided based on the quality of the entries.

DEADLINE

All entries must be (if e-mailed) received by or (if mailed) postmarked by May 31, 2012.
